



**SIXTEENTH AMENDMENT TO
ELSEVIER LICENSE AGREEMENT**

The Licensor shall make available for inspection by a duly authorized auditor of the Subscriber, at the Subscriber's sole expense, the records concerning the calculation of the annual access fee one time per year during regular business hours upon thirty (30) days written notice to the Licensor. The copy may not contain links and other features and functionality associated with the online version.
