

**GENERAL SCIENCE COLLECTION RIDER  
TO THE JSTOR LIBRARY LICENSE AGREEMENT**

This Rider is an addendum to, and incorporates by reference all of the terms of, and any amendments to, the agreement entitled the JSTOR LIBRARY LICENSE AGREEMENT entered into by and between JSTOR and The Regents of the University of California ("Licensee") (the "Agreement") on September 1, 1998. In addition to and in accordance with the terms of the Agreement, Licensee shall hereby participate in the General Science Collection, which shall consist of journals to be released in portions over the course of the year 2000. Information concerning the content of the General Science Cluster is available upon request to JSTOR or at <http://www.jstor.org/about/genosci.list.html>. Notwithstanding any statement incorporated by reference or included herein, the parties hereby agree that University of California, Riverside shall not participate in the General Science Collection at this time, but may participate at any time in the future upon payment of its pro-rata share of the applicable Access Fee identified below.

In connection with the foregoing, the parties hereby agree as follows:

**JSTOR Classification:**

'Very Large': The Berkeley, Los Angeles, Davis, Irvine, Riverside, San Diego, and Santa Barbara campuses of the University of California.

'Large': The Santa Cruz campus of the University of California.

'Very Small': The San Francisco and Merced campuses of the University of California.

**Archive Capital Fee**

The Archive Capital Fee for participation in the JSTOR General Science Collection by all of the campuses identified above shall be \$ \_\_\_\_\_. This fee shall be due and payable thirty (30) days after the date of invoice and is in addition to any agreed upon Database Development Fee(s) for participation in the Phase I Collection.

**Access Fee**

The Access Fee for participation in the General Science Collection by all of the campuses identified above shall be \$ \_\_\_\_\_ and shall be due and payable as of the first day of every calendar year during the initial or renewal terms of the Agreement. This fee is in addition to any agreed upon Annual Access Fee(s) for participation in the Phase I Collection. For the first year, this Access Fee shall be prorated to reflect the number of months remaining in the calendar year following the date of this Rider and shall be due and payable thirty (30) days after the date of invoice. The Access Fee is subject to reasonable annual increases.

In recognition of the fact that the complete General Science collection will be released in portions over the course of the year 2000, Licensee shall be invoiced for one-half of the Access Fee listed above during the first year. Licensee shall be responsible for the full Access Fee after the entire collection is available, beginning in the year 2001.

\*The University of California, Riverside's pro-rata share of this sum shall be \$ \_\_\_\_\_ and shall be payable when ready.

**Payment Terms**

Any payments made more than sixty (60) days after they are due and payable shall be subject to a 10% annual interest charge.
