WHEREAS, ASCE and the Subscriber agrees that it is desirable to allow Authorized Users, as defined below, at the Subscriber's institution to have access to the online versions of the Publishers' titles,

THEREFORE, the parties agree as follows:

1. SCOPE AND COVERAGE

"Licensed Material(s)" refers to electronic versions of those listed journals and other content packages to which the Subscriber maintains a valid online Subscription and which are available through the ASCE Library. This is subject to confirmation by ASCE and amendment due to future Subscription purchases or cancellations. Licensed Materials include any additional features that ASCE may choose to provide, including but not limited to online document delivery services; any restrictions on use apply to all online materials accessed under this Agreement. Please indicate your current journal and other content subscriptions by marking the appropriate boxes in Appendix A of this Agreement.

2. Authorized Site and Users

ASCE grants to the Subscriber and Authorized Users at the Subscriber's Authorized Site online access to the Online Journals for which the Subscriber maintains a current subscription. This grant extends only to the Subscriber and such Authorized Users individually and may not be transferred to, or extended to, others. For purposes of this License, an "Authorized Site" is a localized site (one geographical location) that is under a single administration. For an organization with locations in more than one city, each city is considered to be a different site.

"Authorized Users" means only the employees, faculty, staff, and students officially affiliated with the Subscriber at the Authorized Site, and persons with legal access to the library's collections and facilities at the Authorized Site, using an IP address within the range identified in Appendix B. Authorized Users may be persons remote from the Subscriber's physical location whose access is administered from the Authorized Site, but not persons at remote sites or campuses with separate administrations. For example, an employee of the Subscriber may be considered to be an Authorized User when accessing the Subscriber's network from home or while traveling to another city; however, employees of a branch campus or facility in another city are not considered to be Authorized Users.

The Subscriber will exercise reasonable vigilance and shall be responsible for all access control and security measures necessary to ensure that the Subscriber's IP addresses are not used to access the Online Journals by other than Authorized Users. The Subscriber warrants and represents that common and reasonable methods will be used to inform Authorized Users of general terms and conditions for the use of online information products that are consistent with this License. Furthermore, the Subscriber will make every attempt to enforce the terms of this License upon receiving information from ASCE or any other source that reasonably indicates that one or more Authorized Users is in violation of the terms of this License.

3. IP Addresses

Authorized Users will be recognized and authorized by their Internet address. IP addresses and/or address ranges for the Subscribing Institution are indicated in Appendix B.

4. Authorized Uses.

Licensee and Authorized Users may make all use of the Licensed Materials as is consistent with the Fair Use Provisions of United States copyright laws. In addition, the Licensed Materials may be used for purposes of research, education or other non-commercial use as follows:

Display. Licensee and Authorized Users shall have the right to electronically display the Licensed Materials.

Digitally Copy. Licensee and Authorized Users may download and digitally copy a reasonable portion of the Licensed Materials.

Print Copy. Licensee and Authorized Users may print a reasonable portion of the Licensed Materials.

Recover Copying Costs. Licensee may charge a reasonable fee to cover costs of copying or printing portions of Licensed Materials for Authorized Users.

Archival/Backup Copy. Upon request of Licensee, Licensee may receive from Licensor and/or create one (1) copy of the entire set of Licensed Materials to be maintained as a backup or archival copy during the term of this Agreement, or as required to exercise Licensee's rights of this Agreement.

Licensor acknowledges that Licensee may engage the services of third-party trusted archives, and/or participate in collaborative archiving endeavors to exercise Licensee's rights of this Agreement. Licensor agrees to cooperate with such archiving entities and/or initiatives as reasonably necessary to make the Licensed Materials available for archiving purposes. Licensee may perpetually use the third-party trusted system to access or store the Licensed Materials, so long as Licensee's use is otherwise consistent with this Agreement. Licensor further acknowledges and agrees that, in using the third-party archival system, Licensed Materials may be made available to other system participants who indicate a right to those Licensed Materials.

Caching. Licensee and Authorized Users may make local digital copies of the Licensed materials in order to ensure efficient use by Authorized Users by appropriate browser or other software.

Collections of Information. Licensee and Authorized Users shall be permitted to extract or use information contained in the Licensed Materials for educational, scientific, or research purposes, including extraction and manipulation of information for the purpose of illustration, explanation, example, comment, criticism, teaching, research, or analysis.

Course Reserves (Print and Electronic). Licensee and Authorized Users may use a reasonable portion of the Licensed Materials (i.e. articles, papers, and/or book chapters, but not entire full-length journals, books, or standards) for use in connection with specific courses of instruction offered by the University of California.

Electronic Links. The University of California is committed to the use of the emerging OpenURL standard to allow linking to related materials in other locations. If Licensor does not use the OpenURL standard, Licensor staff will provide information to Licensee upon request to assist the Licensee in creating links directly from UC's library catalogs and licensed resources to the content at the journal, issue and article levels.

Text and Data Mining. The Subscriber and Authorized User(s) who intends to use Licensed Materials as a source for text and data mining purposes, shall contact the Publisher with a proposal to agree upon the scope, purpose, and deal terms of a text and data mining project.

The Subscriber may supply a copy of an article, paper, or book chapter (i.e. Interlibrary Loan) to a non-subscriber or non-subscribing institution only under the following conditions: ASCE-prepared electronic files may not be transmitted in their original digital form to any other institution or to a non-Authorized user. A hard copy printed from the electronic files of the Licensed Materials may be supplied to another institution by mail or fax or secure transmission using Ariel or its equivalent, whereby the electronic file is deleted immediately after printing, provided the institution is not-for-profit and within the same country as the Subscriber. The supply of such copies must conform to CONTU guidelines or similar restrictions to 'fair use' provisions under copyright law.

Faculty at the Subscriber's institution may include articles, papers, and/or book chapters, but not entire full-length journals, books, or standards, from the Licensed Materials in anthologies (coursepacks) in print or digital form for distribution to Authorized Users for their use in connections with classroom instruction or in reserves (print or digital) set up by the Subscribing Institution for access by Authorized Users in connection with specific courses. Copies of items in digital form which are included in online coursepacks or reserves will be deleted by the Subscriber after the end of the semester in which the related course concludes.

Amount of Authorized Use.

Unlimited Access. Subject to the terms of this Agreement, Licensee and its Authorized Users shall have unlimited access to the Licensed Materials.

5. Prohibitions on Certain Uses

The Subscriber shall not knowingly permit anyone other than Authorized Users to use the Licensed Materials. Altering, recompiling, reselling, publishing or republishing of any journal text, output, search results, or other information from the Online Journals, or any portion thereof, including without limitation, copyright, proprietary and/or other legal notices contained therein, in any form or medium is prohibited.

Except as noted in Section 4 – Text Mining, systematic or programmatic downloading, printing, transmitting, or copying of the Licensed Materials is prohibited. "Systematic or Programmatic" means downloading, printing, transmitting, or copying activity of which the intent or the effect is to capture, reproduce, or transfer the entire output of a journal volume, a journal issue, or a journal topical section, or sequential or cumulative search results, or collection of abstracts, articles, or tables of contents. Other such systematic or programmatic use of the Licensed Material that interferes with the access of Authorized Users or that may affect the performance of the ASCE Online Journals system, for example, the use of "robots" to index content, or downloading or attempting to download large amounts of material in a short period of time, is prohibited. Redistribution of the Licensed Material, except as

permitted in Section 4, without permission by ASCE and/or payment of royalty to ASCE or to the appropriate Reproduction Rights Organization, is prohibited.

All rights not expressly granted herein are reserved to ASCE. The Subscriber and Authorized Users may not circumvent ASCE's access control systems or use ASCE's systems or services to make any attempt to gain unauthorized access to any other system or network.

ASCE shall not be required to distribute, and Subscriber shall not redistribute any Online Journal included therein to a country where the export thereof is prohibited by U.S. law or regulation.

6. Duration of License

This Agreement is for the period of January 1, 2016, to December 31, 2016, and extends for 3 years, and becomes effective on receipt by ASCE of the Agreement signed by an authorized agent of the Subscriber and on receipt of payment of the Consortium Access Fee as defined in Section 7.

This agreement shall be renewable at the end of the current term for a successive *length of time* term unless either party gives written notice of its intention not to renew thirty (30) days before expiration of the current term.

In the event that either party believes that the other materially has breached any obligations under this Agreement, or if Licensor believes that Licensee has exceeded the scope of the License, such party shall so notify the breaching party in writing. The breaching party shall have sixty (60) days from the receipt of notice to cure the alleged breach and to notify the non-breaching party in writing that cure has been effected. If the breach is not cured within the sixty (60) day period, the non-breaching party shall have the right to terminate the Agreement without further notice.

Upon Termination of this Agreement for cause online access to the Licensed Materials by Licensee and Authorized Users shall be terminated. Authorized copies of Licensed Materials may be retained by Licensee or Authorized Users and used subject to the terms of this Agreement.

7. Fees and Payment; Price CAP

The Subscriber agrees to pay a Consortium Online Access Fee. The fee is payable upon receipt of an invoice from ASCE. The Consortium Access Fee and the journal print subscription payments (if applicable) are subject to ASCE's annual average price increase for the journals listed in Appendix A. ASCE agrees, however, that **the total price increase for the Consortium Online Access Fee in any given year is not to exceed** [REDACTED]. Only the following adjustments may be made to the journal subscription payments or to the Consortium Online Access Fee:

1. The print copy of any journal received by the Subscriber may be discontinued and the subscription price for that copy will be reduced by a percentage determined by ASCE.
2. A print copy of any journal may be added by a given Subscriber for a percentage of the print and online subscription price for that title, as determined by ASCE.
3. The Consortium may request that new members be added to this Agreement throughout the license period subject to ASCE approval, such approval not to be unreasonably withheld. ASCE may take account of any current or prior subscriptions to ASCE's journals held by such members and may adjust the Consortium Online Access Fee accordingly. All adjustments to the list of Members or IP addresses and to the Consortium Online Access Fee are to be mutually agreed by ASCE and the Consortium.
4. A new title, not initially included in the Licensed Material listed in Appendix A, may be added to this Agreement at any time, at a price to be agreed upon by ASCE and the Consortium.
5. If any journal in Appendix A ceases publication or if ASCE is otherwise unable to provide continued access to any title during the term of this Agreement, the Institution's annual subscription payments and/or Consortium Online Access Fee may be adjusted by agreement between ASCE and the Consortium.

The Subscriber agrees that, with the exceptions listed above, there will be not other reductions or adjustments in the Consortium Online Access Fee for the duration of the Agreement.

8. Copyright

The Online Journals and their content, including abstracts, are copyrighted by ASCE. The Online Journals are subject to all applicable copyright, database protection and other rights of ASCE under the laws of the United States and other countries. Copyright notices in the Online Journals may not be removed, obscured, or modified in any way. Unauthorized copying or redistribution of any ASCE Journal content is a violation of copyright laws.

9. Failure of Performance

ASCE endeavors to provide online service 24 hours a day, 365 days a year. ASCE will announce to subscribers any planned downtime necessary for service upgrades, and will always seek to minimize the length and effect of such downtime. Following online access approval, the Subscriber and Authorized Users will be permitted to attempt online access to the Online Journals at any time. ASCE, however, will not be liable for any delay, downtime, transmission error, software or equipment incompatibilities, force majeure or other failure of performance. ASCE will use commercially reasonable efforts to correct any material performance problem brought to its attention and may suspend performance pending such corrections.

10. Official Version of Record

ASCE will use commercially reasonable efforts to ensure that the online versions of the journals correspond in content with the print versions, but ASCE does not guarantee that they do. In the event of any discrepancy between the print and online versions, the print version will be the official version of record.

11. Usage Rights of Lapsed Subscribers

Notwithstanding anything else in this Agreement, Licensor hereby grants to Licensee to use any Licensed Materials that were accessible during the term of this Agreement to the specific years that Licensor subscribed.

12. Disclaimer of Warranties; Limitation of Liability; Indemnification

ASCE warrants that it is entitled to grant the licenses granted in this License. EXCEPT AS SET FORTH IN THE PRECEDING SENTENCE, ASCE MAKES NO WARRANTY OR REPRESENTATION OF ANY KIND, EXPRESS OR IMPLIED, WITH RESPECT TO THE ONLINE JOURNALS, INCLUDING THEIR QUALITY, ORIGINALITY, SUITABILITY, SEARCHABILITY, OPERATION, PERFORMANCE, COMPLIANCE WITH ANY COMPUTATIONAL PROCESS, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

ASCE SHALL NOT BE LIABLE FOR: EXEMPLARY, SPECIAL, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR OTHER DAMAGES, ARISING OUT OF OR IN CONNECTION WITH THE SUBSCRIPTION OR LICENSES GRANTED HEREUNDER, THE USE OR INABILITY TO USE ANY ASCE ONLINE JOURNAL, ASCE'S PERFORMANCE UNDER THIS LICENSE, TERMINATION OF THIS LICENSE BY ASCE OR THE LOSS OF DATA, BUSINESS OR GOODWILL, EVEN IF ASCE IS ADVISED OR AWARE OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL THE TOTAL AGGREGATE LIABILITY OF ASCE FOR ANY CLAIMS, LOSSES OR DAMAGES ARISING OUT OF ANY BREACH OR TERMINATION OF THIS LICENSE EXCEED THE TOTAL AMOUNT PAID BY THE SUBSCRIBER TO ASCE FOR THE ONLINE JOURNAL SUBSCRIPTION, BUT NOT LESS THAN TWENTY-FIVE DOLLARS (\$25.00), FOR THE CURRENT SUBSCRIPTION YEAR IN WHICH SUCH CLAIM, LOSS OR DAMAGE OCCURRED, WHETHER IN CONTRACT, TORT, OR OTHERWISE, INCLUDING WITHOUT LIMITATION DUE TO NEGLIGENCE. The foregoing limitation of liability and exclusion of certain damages shall apply regardless of the success or effectiveness of other remedies. No claim may be made against ASCE unless suit is filed thereon within one (1) year after the event giving rise to the claim.

The Licensor shall indemnify and hold Licensee and Authorized Users harmless for any losses, claims, damages, awards, penalties, or injuries incurred, including reasonable attorney's fees, which arise from any claim by any third party of an alleged infringement of copyright or any other property right arising out of the use of the Licensed Materials by the Licensee or any Authorized User. NO LIMITATION OF LIABILITY SET FORTH ELSEWHERE IN THIS AGREEMENT IS APPLICABLE TO THIS INDEMNIFICATION.

Each party shall indemnify and hold the other harmless for any losses, claims, damages, awards, penalties, or injuries incurred, including reasonable attorney's fees, which arise from any alleged breach of such indemnifying party's representations and warranties made under this Agreement, provided that the indemnifying party is promptly notified of any such claims.

13. General

This License constitutes the entire agreement between the parties and supersedes any prior communication between the parties with respect to the subject matter hereof. The headings used in this License are for convenience only and are not to be considered in construing the terms of this License. Subject to termination under Section 6, this License may be amended only by consent (via mail, email, or fax) of both parties. If ASCE sends notice to the Subscriber of changes in the terms of this License, lack of response by the Subscriber within a thirty (30) day period will be taken as acceptance of the new terms. Subscriber may not make any changes to this License without written consent by ASCE.

The Subscriber must pay any taxes (including but not limited to any applicable Value Added Taxes, Sales Taxes, and Import Taxes) other than taxes on ASCE's net income, arising out of the Subscriber's use of the Online Journals and/or the rights granted under this License.

The Subscriber may not assign or transfer its rights under this License. The provisions of Sections 2, 4, 5, 7, 9, 10, 11, and 12 hereof shall survive any expiration or termination of this License.

This Agreement shall be interpreted and construed according to, and governed by, the laws of California, excluding any such laws that might direct the application of the laws of another jurisdiction. The federal or state courts located in California shall have jurisdiction to hear any dispute under this Agreement.
