

AMENDMENT

THIS AMENDMENT dated September 5, 2006, is made to the Databases License Agreement with an Effective Date of January 1, 1999 between **Thomson Scientific Inc., f/k/a the Institute for Scientific Information, Inc.**, ("Licensor") and the **Regents of the University of California** ("Licensee"), as such agreement may have been amended or supplemented from time to time ("Agreement"). Effective immediately, the Terms and Conditions of said Agreement are amended as follows:

The Purpose of the Amendment

- To modify and restate the renewal fees for the period January 1, 2007 through December 31, 2009. *This amendment replaces amendment dated April 25, 2006 with corrected fee amounts. aw*

1. Schedule 1: *KRM*

Licensee licenses the following editions of the Database:

- 1900 – 2009 Science Citation Index Expanded (SCIE)
- 1956 – 2009 Social Sciences Citation Index (SSCI)
- 1975 – 2009 Arts & Humanities Citation Index (AHCI)
- 1926 – 2009 BIOSIS Previews (BP)

Licensee's access to the SCIE, SSCI, AHCI and BP Databases shall continue in accordance with the provisions of the terms and conditions of the Agreement, including Section 14, Cease

Access/Erasure of Database.

Current Contents Connect (CCC)

- Life Sciences
- Clinical Medicine
- Agriculture, Biology & Environmental Sciences
- Engineering, Computing & Technology
- Physical, Chemical & Earth Sciences

Licensee's access to CCC shall cease immediately at termination of the Agreement by expiration of its term or otherwise. In the event Licensee chooses to cancel the Agreement, Licensee's access ceases immediately – no further access will be provided.
