

**APPENDIX E – Journal Backfile Collections – Amendment Five**

Licensed Electronic Journal Backfile Collections are the electronic (online) editions of Wiley journal content published in years designated as part of a backfile package to which the Licensee has access under this license, including tables of content, abstracts, full text and illustrations and any additional electronic journal content not included in the print versions of the journals. Journal Backfiles are organized into subject collections.

**Archiving Rights:**

1. Wiley will provide the Licensee with access to the full text of the Licensed Electronic Journal Backfile Collections, either by continuing online access to the same material on Wiley’s server or by means of an archival copy in the electronic medium selected by Wiley, at a cost-based fee agreed to by both parties.
2. Upon request, CDL may receive during the term of the agreement from Wiley the entire set of materials licensed under this agreement and create one (1) copy to be maintained as a backup or archival copy or as required to exercise CDL’s perpetual rights, as stated above. Conditions and terms of use will be exercised pursuant to the terms of the agreement and subsequent amendments.

**Pricing**

Journal Backfile Collection pricing is a one time fee based on the Licensee’s number of FTEs. For this purpose FTEs are defined as full-time equivalent students and academic faculty or employees.
