



**SECOND AMENDMENT TO AIP
ONLINE LICENSE AGREEMENT**

This Amendment to the Publisher Online License Agreement ("Amendment") is effectively dated as of February 17, 2017 (the "Effective Date") by and between AIP PUBLISHING LLC ("Publisher") and The California Digital Library ("Licensee").

RECITALS

WHEREAS, Publisher and Licensee entered into that certain AIP Online License Agreement August 15, 2009 and amended on December 29, 2013, wherein Publisher agreed to provide a license to certain online materials (the "Existing Agreement").

WHEREAS, Publisher and Licensee desire to make certain amendments to the Fees scheduled to be paid for 2017-2020 in the Agreement, as set forth in this Amendment.

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing, of the mutual covenants and agreements hereinafter set forth, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Publisher and Licensee, intending to be legally bound, covenant and agree as follows:

1. **Incorporation of Recitals.** The foregoing Recitals are hereby incorporated in and made a substantive, contractual part of this Amendment by this reference.
2. **Amendment to Existing Agreement Fee Schedule.** Effective as of the Effective Date, the Appendix B: Fees attached to the Existing Agreement shall be amended to restate the 2017-2020 Fees column.
3. **No Other Changes.** All other terms, conditions and provisions of the Existing Agreement remain in full force and effect, except as modified by this Amendment.
4. **Binding Effect.** This Amendment shall be binding upon and inure to the benefit of Publisher and Licensee and their respective permitted successors and assigns.
5. This Amendment will terminate on December 31, 2020.
6. **Counterparts; Electronic Signatures.** This Amendment may be executed in two (2) or more counterpart copies, all of which counterparts shall have the same force and effect as if the parties hereto had executed a single copy of this Amendment. Facsimile or PDF signatures shall be construed as originals.

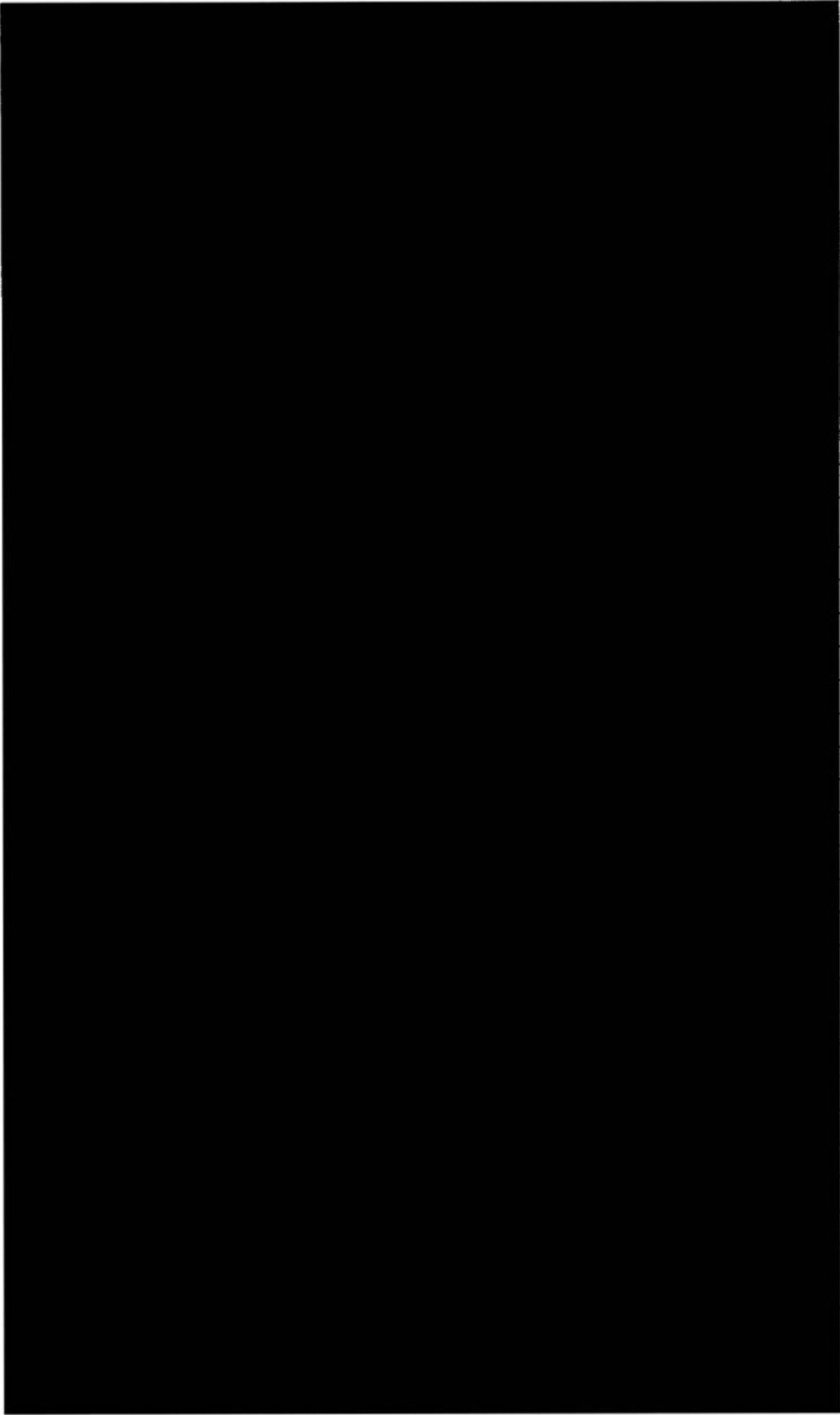

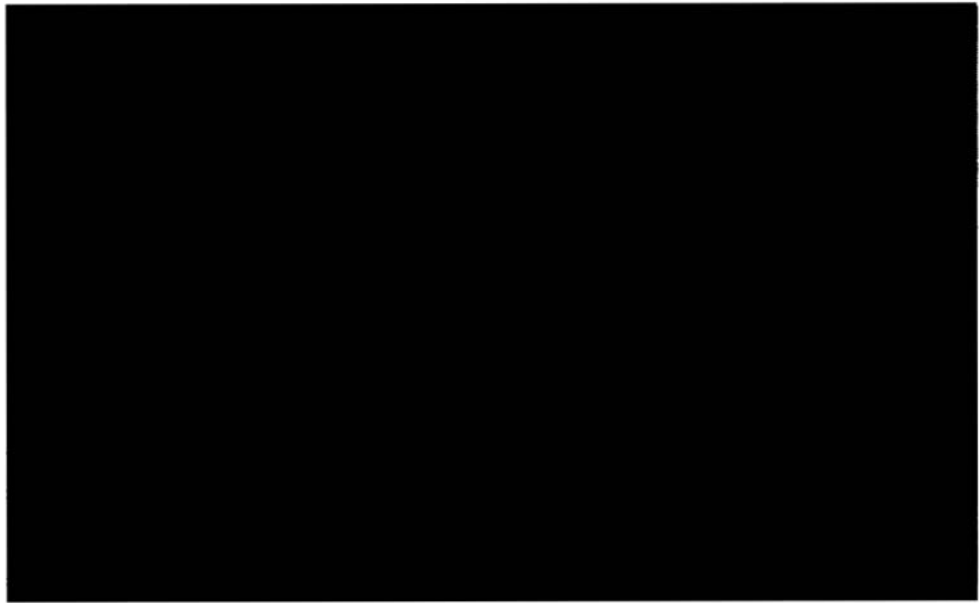
